After careful examination of the above proposals submitted by the Dyios Tirumalagiri Mandal the District Educational Officer, Hyderabad District is pleased to accord ETR for classes I to VII (E.M.) during the year 2012-13 to 2021-2022 in respect of Akshara Vaagdevi International School, Sy.No:703, Bolton Road, Opp- Tivoli Gardens, Trimulgherry, Secunderabad subject to the following conditions.

That the Society shall abide to the rules and regulations made in the Government order fourth cited above.

- That the classrooms with an area of not less than 240 Sq. Feet at the rate one of Market Sq. Feet at the rate one of the square of each section in case of Upper Primary and Scoondary Sections at the rate 1. of one for every 40 students in case of Primary sections shall be provided.
- That adequate accommodation for the staff, Library and Laboratories shall 2. be provided.
- That adequate sanitary facilities and water inch ding drinking water shall be 3. provided.
- That adequate furniture, Library books, Lab. I quipment and play material shall be provided.
- That sufficient number of qualified staff shall be appointed. 5.
- That the educational agencies shall prescribe t e scales of pay to the teaching and non-6.

That the educational institutions shall service the needs of the locality.

That the Educational Institutions shall adopt the surriculum syllabus to the principal street and syllabus to the surriculum syllabus. 8. SECUNDERABAD ooks prescribed by the Government.

- That the Educational Institutions shall follow the school timings mid-term holidays and 9. vacation as prescribed by the Government.
- 10. That the results of the institutions in VII and X class Public examination shall be satisfactory.
- 11. That the administrative report and the audited statement of accounts of the school duly attested by the Chartered Accountant for every financial year shall be submitted to the District Educational Officer, latest by both September.
- 12. That the list of Governing Body shall be furnished to the District Educational Officer every year.
- That the Pay structures/fee structures fixed by the Governing body shall be submitted and get it approved in the District Educational officer.
- 14. That the Educational institutions shall provide facilities for teaching Telugu as First/Second Language in the school.
- 15. That under aged children shall not be admitted or promoted to any class.
- 16. That any children studied in recognized school of other states countries, affiliated to the bodies recognized by the State or Central Government shall not be admitted without prior permission of the District Educational Officer/Director of School Education.
- 17. That any children or an unrecognized school shall not be admitted.
- 18. That the admissions shall not be denied on the grounds of religion caste, race or language.
- 19. That any student shall not the detained in the same class against Government orders.
- 20. That the students shall not be promoted from one class to another class as per the existing Govt. orders.
- 21. That Corporal punishment shall not be imposed to a student.
- 22. That the Management shall not collect any fees or donations either in cash or kind other than the fees prescribed by the Governing body from pupils or parents or any other person or on their behalf for any purpose.
- That any candidate whose certificate is suspended and who as been convicted for offences involving moral, trumpeted shall not be appointed.
- 24. That all records and registers prescribed by Government shall be maintained.
- 25. That the Educational Agency shall not carry on or encourage propaganda or practice wounding the religious feelings of any as of citizens of India or insult the religious belief of that as or indulge in any act that undermine national integrity and insult the national anthem and national flag.
- 26. That educational agency shall not force any member of the staff or students of the institutions to take part in the religious discourses and preaching of religion irrespective of whether they belong to the same belief or not.
- 27. That educational agency shall not refuse to constitute the institution as centers for conducting common public examination like X class, VII class and other departmental examinations as directed by the department.
- 28. That the permission of the competent authority shall be taken to run the institution in shift system.
- 29. That educational agency shall maintain proper sanitary conditions in the institution.

- 30. That educational agency shall take up regular repairs to up keep the school building.
- 31. That educational agency shall not use the premises building, play ground and vacant site belongs to the institution for any purpose other than the institutional activities and conducting authorized examinations without the permission of District Educational Officer.
- 32. That Educational agency shall carry all the instructions issued by the departmental officers relating to making of admissions of students, appointment of staff and other academic and administrative affairs in the interest of academic standards and smooth functioning of the institution.
- 33. That educational agency shall carry all the instructions issued by the departmental officers relating to making of admissions of students, appointments of staff and other academic and administrative affairs in the interest of academic standards and smooth functioning of the Institutions.
- 34. That all the conditions prescribed in the GO,s and other orders which are not specified in the order shall be completed with.
- 35. The management shall apply for the renewal of recognition six months in advance before expiry of the present recognition with all the certificates mentioned in Annexure-I and other decrees or certificates as per G.O.Ms.No. 1 dt. 1-1-1994. The incomplete proposals and the proposals received after due date will not be considered. The Educational Agency will be solely responsible for the non-submission of the proposals in complete shapes on or before the due date.
